1. Information about the changes in the accounting policy during the reporting period, the reasons for their making and in what way they impact on the issuer's financial result and equity

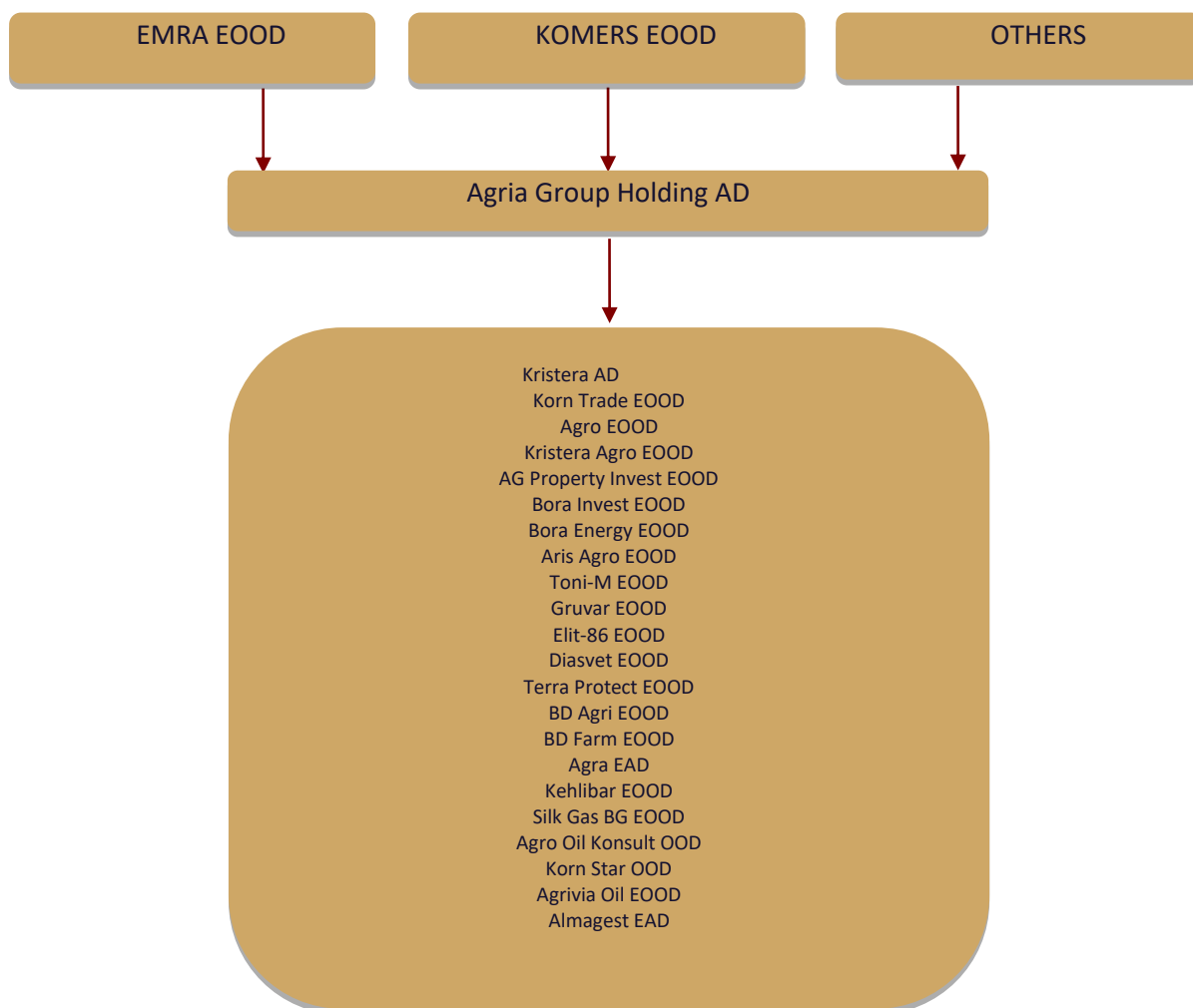
There was no change in the accounting policy of Agria Group Holding AD in the first reporting half of 2023.

Changes in the business group of "Agria Group Holding" AD occurred in the first reporting half of 2023.

"Agria Group Holding" AD has acquired 100% of the shares of the capital of "Almagest" AD, a trading company operating in the field of storage and processing of grain for bioethanol production and in the field of trading in grain and ethanol produced from it.
