Transaction performed on behalf of a person ("Emra" EOOD), closely related to a person (Emil Veselinov Raykov), performing management functions in the Issuer "Agria Group Holding" AD with UIC 148135254, whose shares are admitted to trade on a regulated securities market.

4. Description and identifier of the financial instrument  
160,000 ordinary, registered, dematerialized shares with voting rights in the capital of Agria Group Holding AD with a nominal value of one lev each

5. Nature of the transaction  
Acquisition directly by purchase of 160 000 ordinary, registered, dematerialized shares with voting rights in the capital of Agria Group Holding AD with a nominal value of one lev each, the rights to which may be exercised in the General Meeting of Agria Group Holding AD, representing 2.35% of the capital of Agria Group Holding AD. The current situation regarding the voting rights (shares held after the transaction) of "Emra" EOOD is as follows: 2 955 500 shares, representing 43.46% of the capital of the public company. The voting rights are calculated on the basis of the total number of shares with voting rights, based on the most recently disclosed information by the public company on the total number of shares with voting rights and the amount of the capital, namely: 6 800 000 BGN (six million and eight hundred thousand levs), distributed in 6 800 000 (six million and eight hundred thousand) ordinary, registered, dematerialized shares with voting rights with a nominal value of 1 (one) lev each.
